Candidates will have to pass through the Screening Process and **Medical Examination**, before being adjudged as suitable for selection. Candidates, who fail in the prescribed medical test, *will not* be given any alternative employment and decision of the Corporation is final on this issue. #### 5. CHARACTER & ANTECEDENTS:

The success in the examination does not confer any right to appointment unless the corporation is satisfied after such an inquiry, as may be considered necessary, that the candidate having regard to his/her character and antecedents is suitable in all respects for appointment to the service.

#### 6. SURETY BOND:

The candidates selected for post of Deputy General Manager (Finance) & Assistant Manager (Finance) will have to execute a surety bond of **Rs. 4,00,000/- & Rs. 3,00,000/- respectively along with the cost of training and applicable service tax to serve the corporation for a minimum period of three years (exclusive of the period in which one remained on LWP or EOL) and also a three months prior notice, will be required before seeking resignation from the corporation.** 

#### 7. PROBATION:
