Applications are invited from eligible Indian Citizens, for recruitment against Scouts & Guides quota in Group 'C' posts in Pay Scale ₹ 5200-20200, Grade Pay ₹ 1900/₹ 2000 in the prescribed format given in this notice.

(1) **Vacancies** : 02 (TWO). (No post is reserved for any particular community)

(2) **Essential Qualifications** : (A) **Educational**: (i) **For Technician-III**: Matriculation or its equivalent with ITI in relevant trade (Recognised by SCVT, NCVT). (ii) **For other posts**: Matriculation or its equivalent with 50% mark in aggregate. For candidates having higher qualification than 10th class, 50% marks in 10th class is not necessary (B) **Scouting** : (a) A President's Scout/Guide/Ranger/Rover or Himalayan Wood Badge holder or a pre-HWB trained Scouts/Leader/Advanced Trained Guide/ Leader/Captain. (b) Should have been an active member of a Scouts Organisation for atleast 3 years in the recent past (i.e., 2010-11, 2011-12 and 2012-13) and should continue to be active. (c) Should have attended at least one event at National level and one or Two events at State level or should have a good record of participation in Scouts/Guide activities at Unit/District level.

(3) **Age: 18 to 33 years**: (i) Age will be reckoned as on 01-01-2014. (ii) Age relaxation for SC/ST Candidates- 5 years, OBC Candidates-3 years (A certificate on the prescribed format for employment under Central Govt. to be attached) and ESM, Handicapped etc., candidates are also eligible of age relaxation as per norms.

(4) **How to apply**: (i) Candidates should carefully read all the instructions given in the employment notice before filling the application form. (ii) Application shall be submitted on a good quality white plain A4 size. paper in the format given as Annexure-I in the Employment Notice. (iii) The application should be filled in with capital letters either in English or Hindi only. (iv) The application form should be filled by the applicant in his own handwriting using a blue or black ball point pen only. (v) Serving Government employees should send their applications through proper channel duly forwarded by their controlling officer. The last date will not be extended on account of delay in transmission of the application by the concerned office. However an advance copy of the application can also be submitted. (vi) Candidates belonging to SC/ST community shall submit their attested xerox copies of community certificates as issued by the appropriate State Government authorities.

(6) **EXAMINATION FEES**: ♦ The examination fee of ₹ 40/- (Rupees forty only) is payable in the form of Indian Postal Orders (IPO), drawn in favour of **Assistant Personnel Officer/Recruitment, RRC N.E. Railway, payable at Gorakhpur**. ♦ IPOs issued before the date of issue of this Employment Notice or after the closing date will not be accepted and the Application Form will be rejected. ♦ Applications received with Cash / Cheque/Central Recruitment Fee Stamps and Money Orders will not be accepted and will be REJECTED. ♦ Candidates must write their name, full address at the space provided in the postal order. ♦ The examination fee is not refundable / transferable/ adjustable under any circumstances. ♦ **FEE EXEMPTIONS** : SC/ST candidates, Ex-Servicemen, Persons with Disabilities, Women candidates, Minority candidates and candidates belonging to OBC except Crimilayer i.e. Economically Backward Classes are exempted from payment of examination fees. **Note**: Minorities will mean Muslims, Christians, Sikhs, Buddhists and Zorastrians (Parsis). Economically backward classes will mean the candidates whose family income is less than the prescribed income limit.

(7) **Mode of Selection & Recruitment process**: (i) The candidates, who apply in response to the notification issued and are found eligible for consideration for appointment against Scouts & Guides quota should be assessed on the following basis.

(A) **Written Test-50 marks**.: The written examination will consist of 50 objective type questions relating to Scouts and Guides organization and its activities as per the syllabus mentioned in this notification (B) **Scouts/Guides qualifications over and above the minimum prescribed as eligibility condition**.-35 marks. (i) Participation in International event-one event-5 marks, two or more events-7 marks. (ii) Participation in National Events/National Jamboree-(No marks for first event. The same being the minimum eligibility condition. First additional event-5 marks, two additional events or beyond-7 marks) (iii) Participation in Jamboree on Indian Railway (one event-5 marks, two or more events-7 marks) (iv) Events/Rallies attended at State level (one event-5 marks, two or more events-7 marks) (v) Specialized Scout/Guide course Pioneering/ Mapping and standard judging course/vocational craft course (one course-5 marks, two or more courses-7 marks) (C) **Personality test/Interview-15 marks**. The final empanelment to the tune of the notified vacancies will be based on the Final Merit Order prepared based on the marks obtained by the candidate in the written test, personality test/interview and the marks assigned to the Scouts/Guides qualifications etc.
